### Accrued Interest



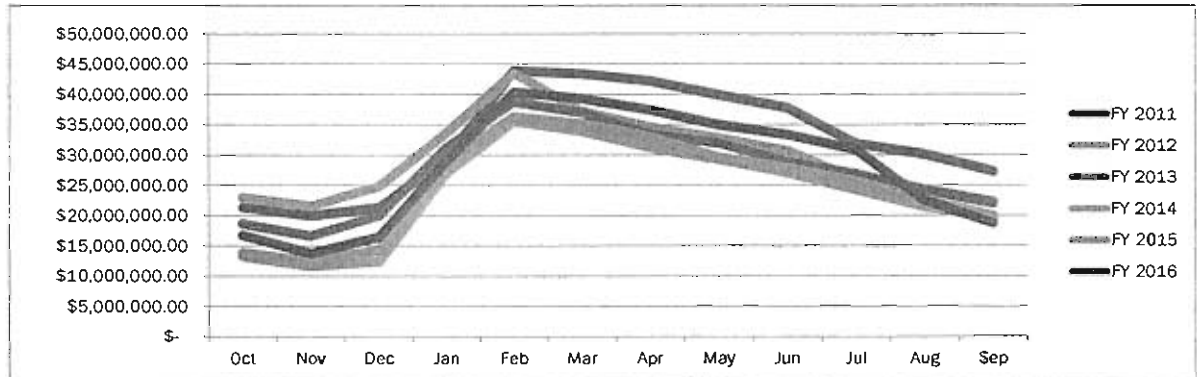
