COMMISSIONERS COURT ORDER RELEASING IRREVOCABLE LETTER OF CREDIT NUMBER 3300095177 FROM BYRD HOMES LLC, FOR THE SUM OF \$60,000.00, SECURED BY PINNACLE BANK, FOR THE CONSTRUCTION OF ROADS, STREETS, DRAINAGE AND SIGNAGE FOR WESTOVER HILLS, PHASE 4, IN PRECINCT #1
