"REDUCE SPEED LIMIT TO 20 MPH ON CR 705 BEGINNING AT THE INTERSECTION OF CR 805 AND CR 705 FOR A DISTANCE OF 0.3 MILES AND REDUCING THE SPEED LIMIT FROM THAT POINT ON CR 705 TO 30 MPH FOR A DISTANCE OF 0.6 MILES TO THE INTERSECTION OF CR 705 AND BARTON ROAD" IN JOHNSON COUNTY, TEXAS-PRECINCT #4

The Johnson County Commissioners Court met on June 14, 2021 in regular session and held a public hearing to consider "Reduce Speed Limit to 20 MPH on CR 705 Beginning at the Intersection of CR 805 and CR 705 for a Distance of 0.3 Miles and Reducing the Speed Limit from that point on CR 705 to 30 MPH for a Distance of 0.6 Miles to the Intersection of CR 705 and Barton Road" in Johnson County, Texas-Precinct #4.

The Public Hearing was properly published in the Cleburne Times Review on Saturday, June 5, 2021 on the County Web Page and on the bulletin board of the Johnson County Commissioners Court at the Johnson County Courthouse.

A motion was made by Commissioner Woolley, Pct. #4 and seconded by Commissioner White, Pct. #3 to approve "Reduce Speed Limit to 20 MPH on CR 705 Beginning at the Intersection of CR 805 and CR 705 for a Distance of 0.3 Miles and Reducing the Speed Limit from that point on CR 705 to 30 MPH for a Distance of 0.6 Miles to the Intersection of CR 705 and Barton Road" in Johnson County, Texas-Precinct #4. Said motion was approved by unanimous vote of the Commissioners Court on the 14th day of June, 2021.
