COUNTY OF JOHNSON

ORDER RATIFYING PROPERTY TAX INCREASE
FOR THE 2021 TAX YEAR

WHEREAS, the Commissioners Court of Johnson County, Texas has approved the Annual Budget for Johnson County for Fiscal Year 2021-2022; and

WHEREAS, the Commissioners Court of Johnson County, Texas has proposed to adopt a tax rate for the 2021 Tax Year to fund the Annual Budget for Johnson County for Fiscal Year 2021-2022; and

WHEREAS, the adoption of said Annual Budget for Johnson County for Fiscal Year 2021-2022 will require raising more revenue from property taxes than in the previous year; and

WHEREAS, the adoption of a budget that will require raising more revenue from property taxes than in the previous year requires a separate vote of the Commissioners Court to ratify the property tax increase reflected in the budget.

NOW THEREFORE, BE IT ORDERED BY THE COMMISSIONERS COURT OF JOHNSON COUNTY, TEXAS:

That pursuant to Section 111.008 (c) of the Local Government Code, the Commissioners Court of Johnson County, Texas does hereby ratify the property tax increase for the 2021 Tax Year reflected in the Annual Budget for Johnson County for Fiscal Year 2021-2022.

Said vote was based upon the motion: "I move that the Commissioners Court ratify the property tax increase for the 2021 Tax Year reflected in the Annual Budget for Johnson County for Fiscal Year 2021-2022".
