COMMISSIONERS COURT ORDER RELEASING FUNDS IN THE AMOUNT OF \$84,240.00, PAYABLE TO DEYANIRA A. GAONA, FOR SECURING CONSTRUCTION OF ROADS, STREETS, DRAINAGE AND SIGNAGE IN GAONA ESTATES, PHASE 2, IN PRECINCT #3

The Johnson County Commissioners Court met on December 27, 2021 in regular session for the consideration of the release of funds in the amount of \$84,240.00, payable to Deyanira A. Gaona, for securing Construction of Roads, Streets, Drainage and Signage in Gaona Estates, Phase 2, in Precinct #3.
