COMMISSIONERS COURT ORDER GRANTING AN EXEMPTION UNDER SECTION 262.024, LOCAL GOVERNMENT CODE, FROM THE BIDDING REQUIREMENTS OF SECTION 262.023, LOCAL GOVERNMENT CODE, UPON THE COMMISSIONERS COURT FINDING THAT CODING, PROGRAMING & BALLOT PRINTING SERVICES FOR THE ELECTIONS SYSTEMS & SOFTWARE (ES&S) EQUIPMENT PROVIDED BY ELECTIONS SYSTEMS & SOFTWARE (ES&S) IS A SERVICE THAT CAN BE OBTAINED FROM ONLY ONE SOURCE

The Johnson County Commissioners Court met on November 14, 2022, in regular session for the consideration that the coding, programing and ballot printing services for the Elections Systems & Software (ES&S) equipment provided by Elections Systems & Software (ES&S) is a service that can be obtained from only one source. The Commissioners Court finds that the coding, programing and ballot printing services provided by Elections Systems & Software (ES&S) is a service that can be obtained from only one source, and that the Commissioners Court may grant an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code as no other company provides the coding, programing and ballot printing services in Johnson County, Texas.

A motion was made by Commissioner Howell, Pct. #2 seconded by Commissioner White, Pct. #3 that: "The Commissioners Court finds that that the coding, programing and ballot printing services provided by Elections Systems & Software (ES&S) for the Elections Systems & Software equipment provided by Elections Systems & Software (ES&S) is a service that can be obtained from only one source and that the Commissioners Court may grant an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code as no other company provides the coding, programing and ballot printing services provided by Elections Systems & Software (ES&S) in Johnson County, Texas".

The Commissioners Court of Johnson County, Texas does hereby enter this Order granting an exemption under Section 262.024, Local Government Code, from the bidding requirements of Section 262.023, Local Government Code, upon the Commissioners Court finding that that the coding, programing and ballot printing services provided by Elections Systems & Software (ES&S) for the Elections Systems & Software equipment provided by Elections Systems & Software (ES&S) in Johnson County, Texas is a service that can be obtained from only one source.
