COUNTY OF JOHNSON

COMMISSIONERS COURT ORDER GRANTING AN EXEMPTION UNDER SECTION 262.024, LOCAL GOVERNMENT CODE, FROM THE BIDDING REQUIREMENTS OF SECTION 262.023, LOCAL GOVERNMENT CODE, UPON THE COMMISSIONERS COURT FINDING THAT THE PURCHASE OF A VEHICLE FOR PRECINCT 4 IS A PURCHASE DUE TO A CASE OF PUBLIC CALAMITY (EMERGENCY) AND IT IS NECESSARY TO MAKE THE PURCHASE PROMPTLY TO PRESERVE THE PROPERTY OF THE COUNTY

The Johnson County Commissioners Court met on **May 8, 2023** in regular session for the consideration of a purchase for Precinct 4 of a 2022 Ford Super Duty F-250 truck from Southwest Ford, Inc. The Commissioners Court finds that this vehicle purchase is a vehicle that must be purchased in a case of public calamity (emergency) and it is necessary to make the purchase promptly to preserve the property of the county and that the Commissioners Court may grant an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code.

A motion was made by Commissioner Woolley, Pct. 4 and seconded by Commissioner Bailey, Pct. 1 that "The Commissioners Court finds the vehicle purchase is a vehicle that must be purchased in a case of public calamity (emergency) and it is necessary to make the purchase promptly to preserve the property of the county and that the Commissioners Court grants an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code, and enter an Order to that affect, and that the Commissioners Court approve the purchase of the 2022 Ford Super Duty F-250 truck from Southwest Ford, Inc."

Said motion was approved by a vote of the Commissioners Court on the 8TH DAY OF MAY, 2023.

The Commissioners Court of Johnson County, Texas does hereby enter this Order granting an exemption under Section 262.024, Local Government Code, from the bidding requirements of Section 262.023, Local Government Code, upon the Commissioners Court finding that the vehicle purchase is a vehicle that must be purchased in a case of public calamity (emergency) and it is necessary to make the purchase promptly to preserve the property of the county and that the Commissioners Court grant an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code.
