COMMISSIONERS COURT ORDER PURSUANT TO SECTION 615.001, LOCAL GOVERNMENT CODE ESTABLISHING PARKING RESTRICTIONS ON THE PARKING LOT COMMONLY KNOWN AS AND REFERRED TO HEREIN AS THE "BANK PARKING LOT"

The Johnson County Commissioners Court met on January 11, 2016 in a regular session for the consideration of establishing parking restrictions pursuant to Section 615.001 of the Local Government Code on the parking lot which is located west of Mill Street, south of Henderson Street, east of Hillsboro Street and north of Chambers Street and commonly known as and referred to herein as the "Bank Parking Lot". The Commissioners Court finds that parking restrictions are necessary in order to provide parking for employees of Johnson County, employees of Bank of America, a tenant of Johnson County, and to restrict certain parking spaces to parking for persons entering the Bank of America Building for conducting business with Johnson County and/or Bank of America and to authorize the Public Works Department to post signage at the entrance to the Bank Parking Lot to inform the public of the parking restrictions and to label each individual parking space with the appropriate parking restriction and to further authorize the towing of any vehicle parked in violation of any parking restrictions.

A motion was made seconded by Commissioner County Judge Roger Harmon that: "The Commissioners Court place parking restrictions on the Bank Parking Lot between the hours of 7:00 a.m. to 6:00 p.m. Monday through Friday, and between the hours of 7:30 a.m. to 1:00 p.m. on Saturdays to restrict certain parking spaces for employees of Johnson County and employees of Bank of America by permit and to restrict certain parking spaces to parking for persons entering the Bank of America Building for conducting business with Johnson County and/or Bank of America and authorizing the Public Works Department to post signage at the entrance to the Bank Parking Lot to inform the public of the parking restrictions and to label each individual parking space with the appropriate parking restriction and to further authorize the towing of any vehicle parked in violation of any parking restriction."

The Commissioners Court of Johnson County, Texas does hereby enter this order placing parking restrictions on the Bank Parking Lot between the hours of 7:00 a.m. to 6:00 p.m. Monday through Friday, and between the hours of 7:30 a.m. to 1:00 p.m. on Saturdays to restrict certain parking spaces for employees of Johnson County and employees of Bank of America by permit and to restrict certain parking spaces to parking for persons entering the Bank of America Building for conducting business with Johnson County and/or Bank of America and authorizing the Public Works Department to post signage at the entrance to the Bank Parking Lot to inform the public of the parking restrictions and to label each individual parking space with the appropriate parking restriction and to further authorize the towing of any vehicle parked in violation of any parking restriction.
