COMMISSIONERS COURT ORDER GRANTING AN EXEMPTION UNDER SECTION 262.024, TEX. LOCAL GOVERNMENT CODE, FROM THE BIDDING REQUIREMENTS OF SECTION 262.023, TEX. LOCAL GOVERNMENT CODE, UPON THE COMMISSIONERS COURT FINDING THAT THE MENTAL HEALTH SERVICES PROVIDED BY DR. ERICA SWICEGOOD, M.D. ARE PROFESSIONAL SERVICES

The Johnson County Commissioners Court met on December 11, 2023 in regular session for the consideration of a contract between Johnson County, Texas and Dr. Erica Swicegood, M.D., the Commissioners Court finds that this contract is for professional services and that the Commissioners Court may grant an exemption under Section 262.024, Tex. Local Government Code, from the competitive bidding requirements of Section 262.023, Tex. Local Government Code.
