COMMISSIONERS COURT ORDER GRANTING AN EXEMPTION UNDER SECTION 262.024, LOCAL GOVERNMENT CODE, FROM THE BIDDING REQUIREMENTS OF SECTION 262.023, LOCAL GOVERNMENT CODE, UPON THE COMMISSIONERS COURT FINDING THAT THE SERVICES PROVIDED BY FREESE AND NICHOLS, INC. TO DEVELOP A TRANSPORTATION BOND PROGRAM FOR JOHNSON COUNTY IS A PROFESSIONAL SERVICE

The Johnson County Commissioners Court met on July 8, 2024, in regular session for the consideration of a Professional Services Agreement between Johnson County, Texas and Freese and Nichols, Inc. to develop a transportation bond program for Johnson County. The Commissioners Court finds that this Professional Services Agreement to develop a transportation bond program for Johnson County is a contract for professional services and that the Commissioners Court may grant an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code.

NOW THEREFORE BE IT ORDERED:

The Commissioners Court of Johnson County, Texas does hereby enter this Order granting an exemption under Section 262.024, Local Government Code, from the bidding requirements of Section 262.023, Local Government Code, upon the Commissioners Court finding that the Professional Services Agreement between Johnson County, Texas and Freese and Nichols, Inc. to develop a transportation bond program for Johnson County is a contract for professional services.
