ORDER AUTHORIZING BARNETT GATHERING, L.P. TO FILE AN INSTRUMENT CANCELING THE COUNTRY OAKS ESTATES, SECTION ONE IN JOHNSON COUNTY, TEXAS, PRECINCT 3

WHEREAS, Texas Local Government Code Section 232.008 allows the owner of subdivided real property to petition the Commissioners Court to cancel a subdivision; and

WHEREAS, Barnett Gathering, L.P. has filed a petition with Johnson County seeking permission to cancel the entirety of the Country Oaks Estates, Section One; and

WHEREAS, Texas Local government Code Section 232.008 (b) states that a county "shall authorize the owner of the subdivision to file an instrument canceling the subdivision" if all owners of property in the subdivision agree to the cancellation so long as the cancellation does not interfere with transportation infrastructure; and

WHEREAS, Barnett Gathering, L.P. owns all of the real property contained within the Country Oaks Estates, Section One.

THEREFORE, BE IT ORDERED, ADJUDGED, AND DECREED that the Commissioners Court hereby GRANTS the Application to Cancel the Country Oaks Estates, Section One, and AUTHORIZES Barnett Gathering, L.P. to file an instrument canceling the Country Oaks Estates, Section One with the Deed Records of Johnson County, Texas.


