Monthly Interest Income



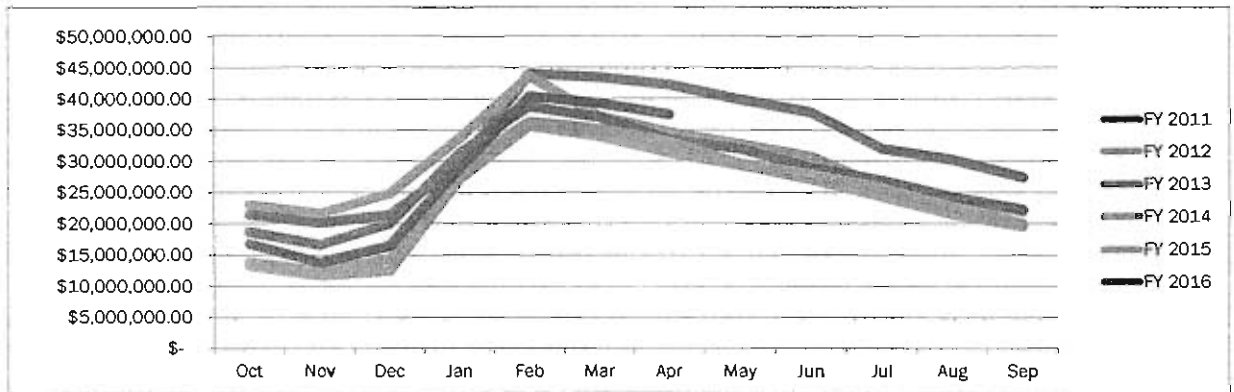




