**COMMISSIONERS COURT ORDER GRANTING AN EXEMPTION UNDER SECTION 262.024, LOCAL GOVERNMENT CODE, FROM THE BIDDING REQUIREMENTS OF SECTION 262.023, LOCAL GOVERNMENT CODE, UPON THE COMMISSIONERS COURT FINDING THAT THE DENTAL SERVICES PROVIDED BY DR. ERIC BRAUNLIN, D.D.S. ARE PROFESSIONAL SERVICES**

The Johnson County Commissioners Court met on October 24, 2016 in regular session for the consideration of a contract between Johnson County, Texas and Dr. Eric Braunlin, D.D.S., the Commissioners Court finds that this contract is for professional services and that the Commissioners Court may grant an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code.

A motion was made by Commissioner Rick Bailey and seconded by Commissioner Kenny Howell that: "The Commissioners Court find the contract for dental services provided by Dr. Eric Braunlin, D.D.S. is a contract for professional services and that the Commissioners Court grants an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code, and enter an order to that affect, and that the Commissioners Court approve the contract for dental services with Dr. Eric Braunlin, D.D.S."

Said motion was approved by unanimous vote of the Commissioners Court on the 24<sup>th</sup> day of October, 2016.

**NOW THEREFORE BE IT RESOLVED AND ORDERED:**

The Commissioners Court of Johnson County, Texas does hereby enter this order granting an exemption under Section 262.024, Local Government Code, from the bidding requirements of Section 262.023, Local Government Code, upon the Commissioners Court finding that the contract for dental services with Dr. Eric Braunlin, D.D.S., is a contract for professional services.






