SECTION 262.023, LOCAL GOVERNMENT CODE, UPON THE COMMISSIONERS COURT FINDING THAT PARAMEDIC CARE AND AMBULANCE SERVICES FOR JOHNSON COUNTY ARE AN ITEM NECESSARY TO PRESERVE OR PROTECT

THE PUBLIC HEALTH OR SAFETY OF THE RESIDENTS OF JOHNSON COUNTY
