DESIGNATION AND INSTALLATION OF NO PARKING SIGNAGE ON EACH SIDE OF THE ROAD FOR THE FIRST 1000 FEET OF CR 711A (ALSO KNOWN AS COLLINS RD) FROM THE INTERSECTION OF CR 711A AND FM 731 IN JOHNSON COUNTY, TEXAS - PRECINCT #4 (CR 711A/COLLINS RD IS LOCATED ADJACENT TO THE NICHOLS MIDDLE SCHOOL CAMPUS IN JOSHUA ISD)

The Johnson County Commissioners Court met on October 13, 2017 in regular session and held a public hearing to consider "Designation and Installation of no Parking Signage on Each Side of the Road for the First 1000 Feet of CR 711A (also known as Collins Rd) from the Intersection of CR 711A and FM 731 in Johnson County, Texas – Precinct #4" (CR 711A/Collins Rd is Located Adjacent to the Nichols Middle School Campus in Joshua ISD.)

The Public Hearing was properly published in the Cleburne Times Review, on the County Web Page and on the bulletin board of the Johnson County Commissioners Court at the Johnson County Courthouse on Saturday, September 30, 2017.

A motion was made by Commissioner Woolley and seconded by Commissioner Howell to approve "Designation and Installation of no Parking Signage on Each Side of the Road for the First 1000 Feet of CR 711A (also known as Collins Rd) from the Intersection of CR 711A and FM 731 in Johnson County, Texas – Precinct #4" (CR 711A/Collins Rd is Located Adjacent to the Nichols Middle School Campus in Joshua ISD.) 




