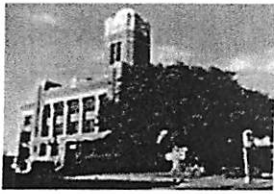

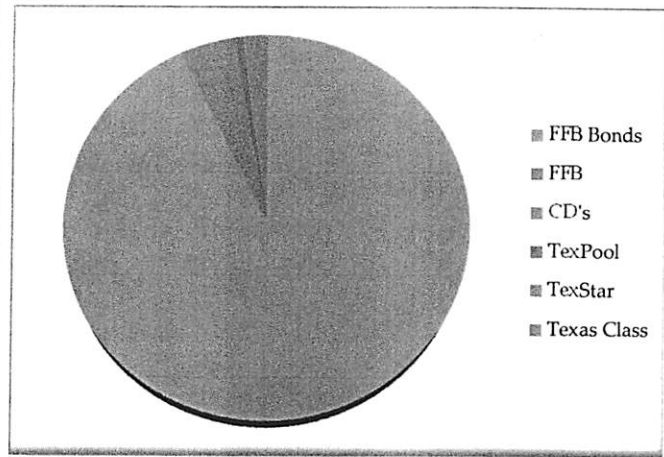
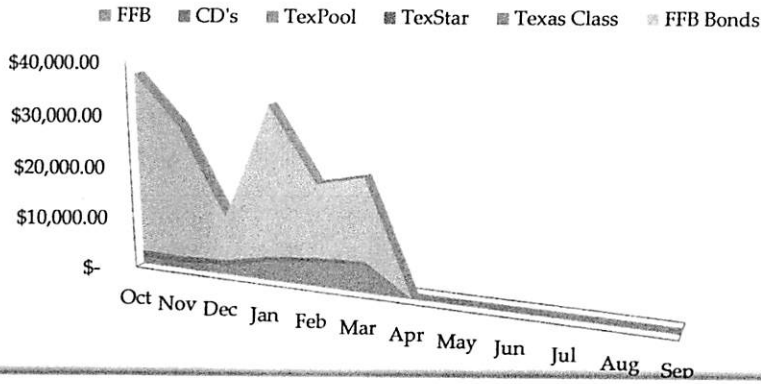

Monthly Interest Income



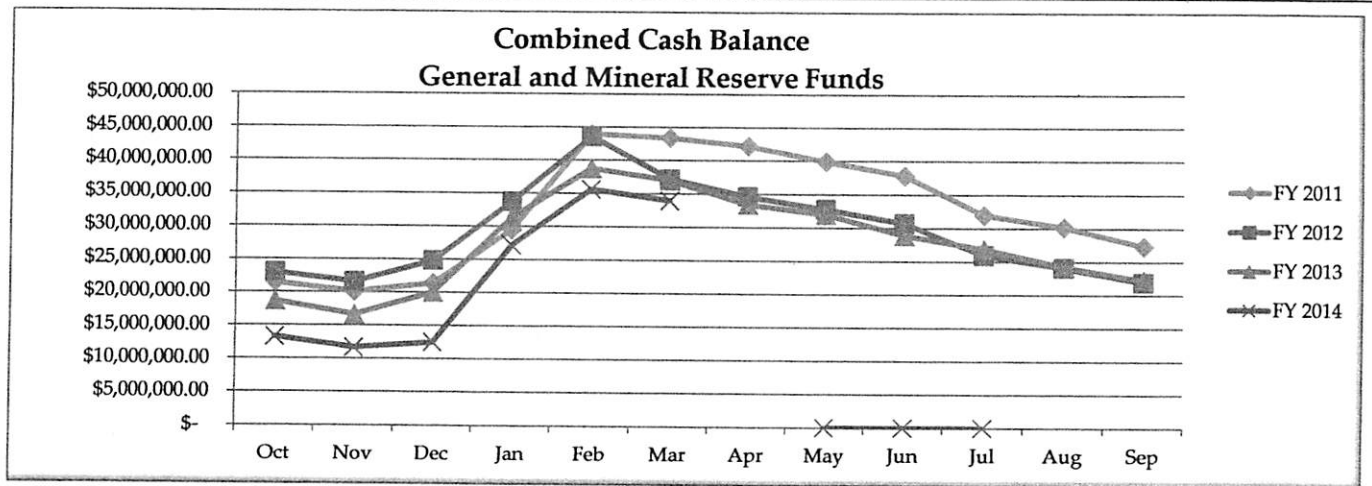


