

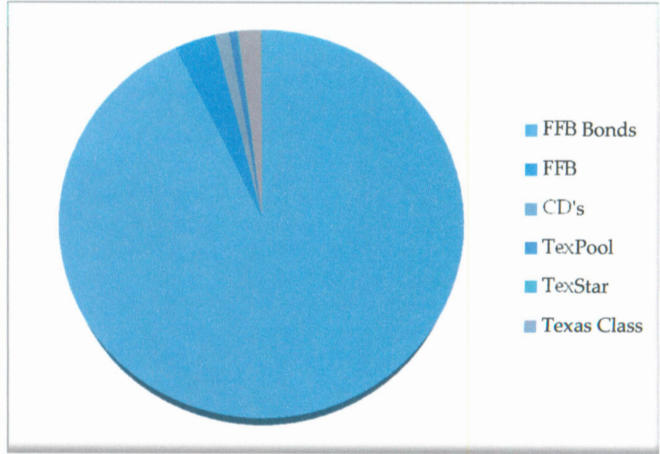
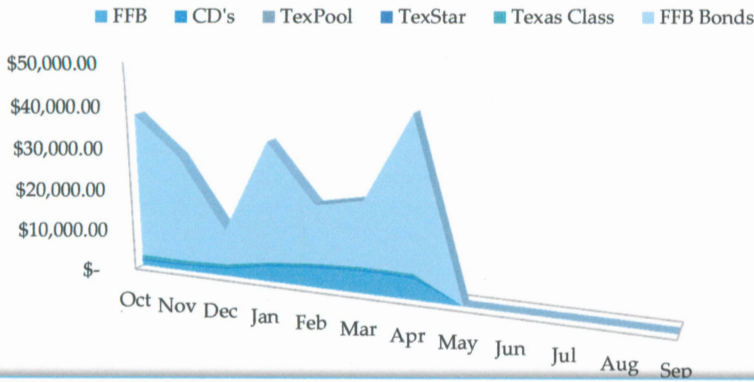

## Monthly Interest Income



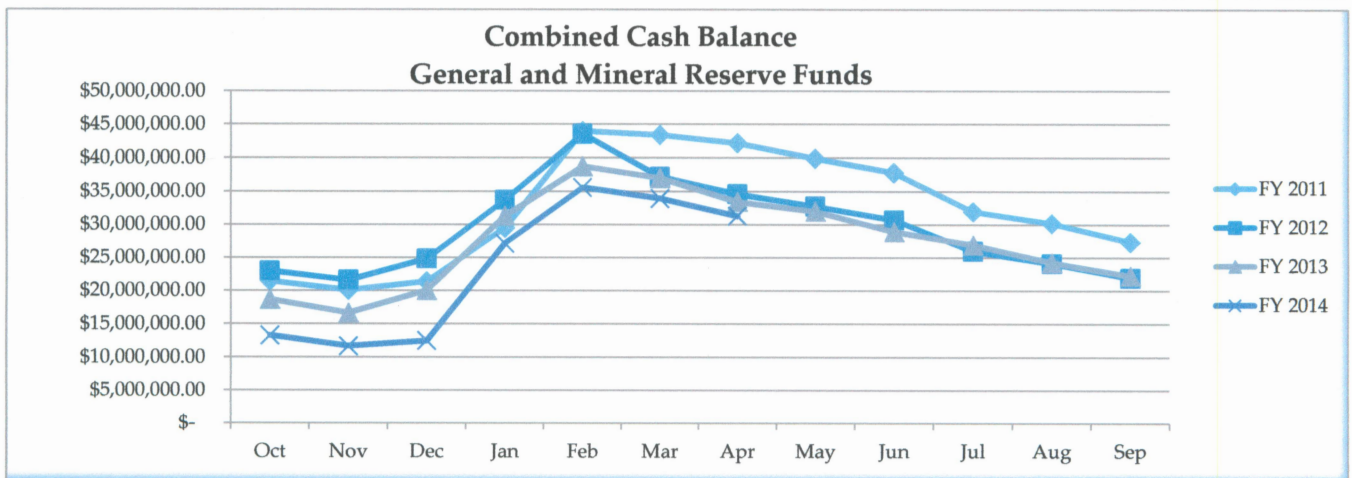
