Monthly Interest Income



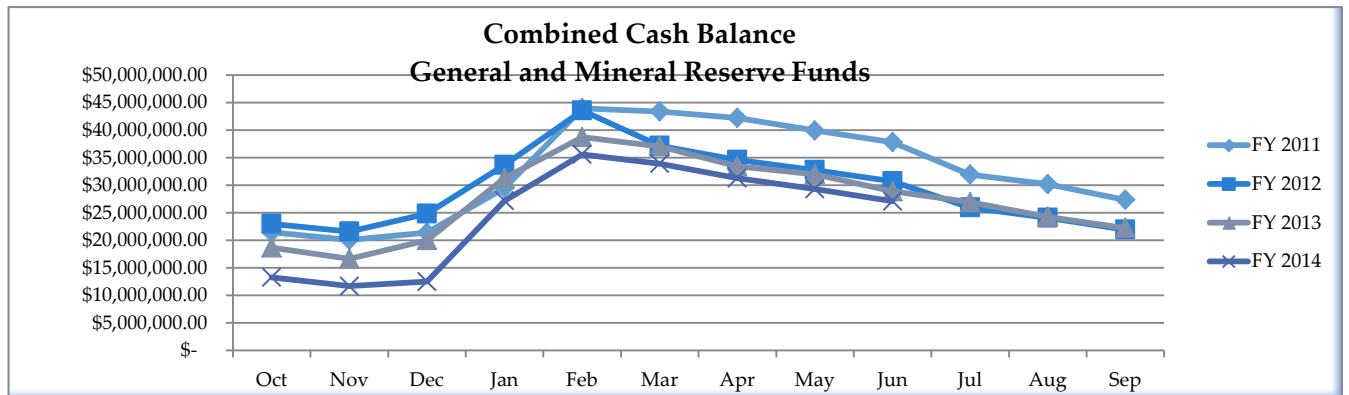
