

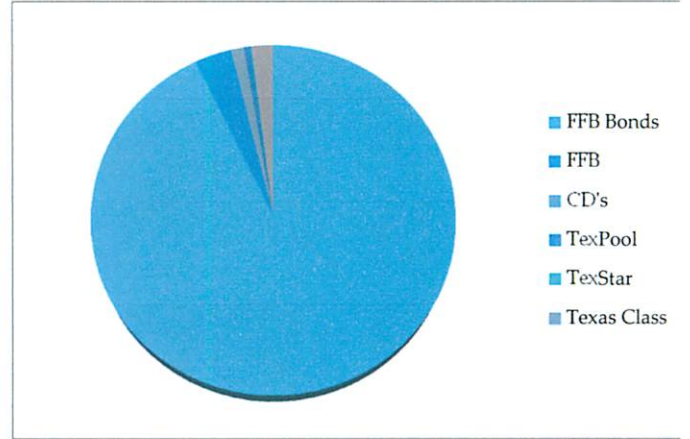
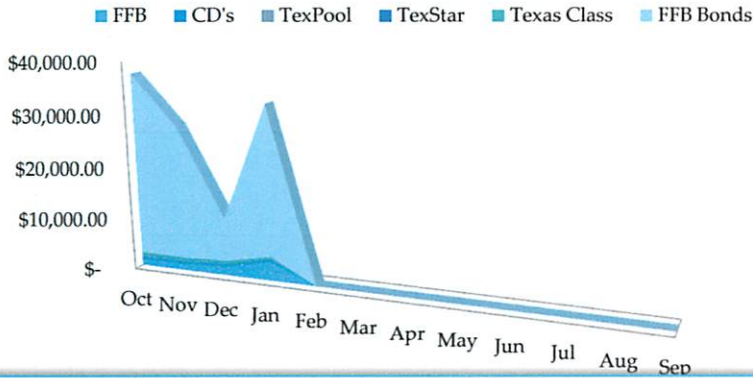

Monthly Interest Income



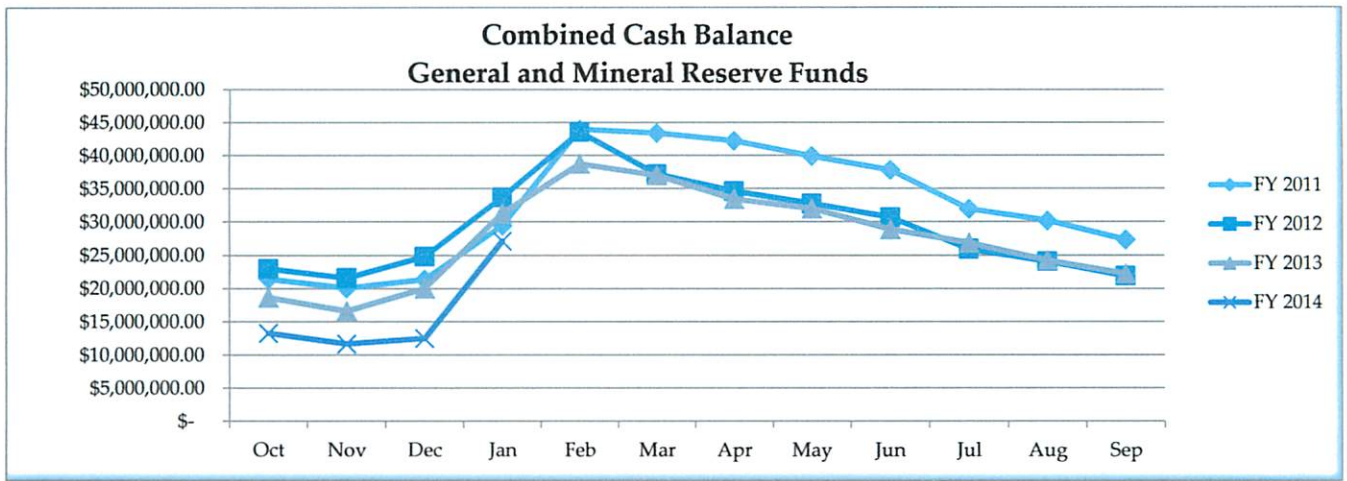




