Monthly Interest Income



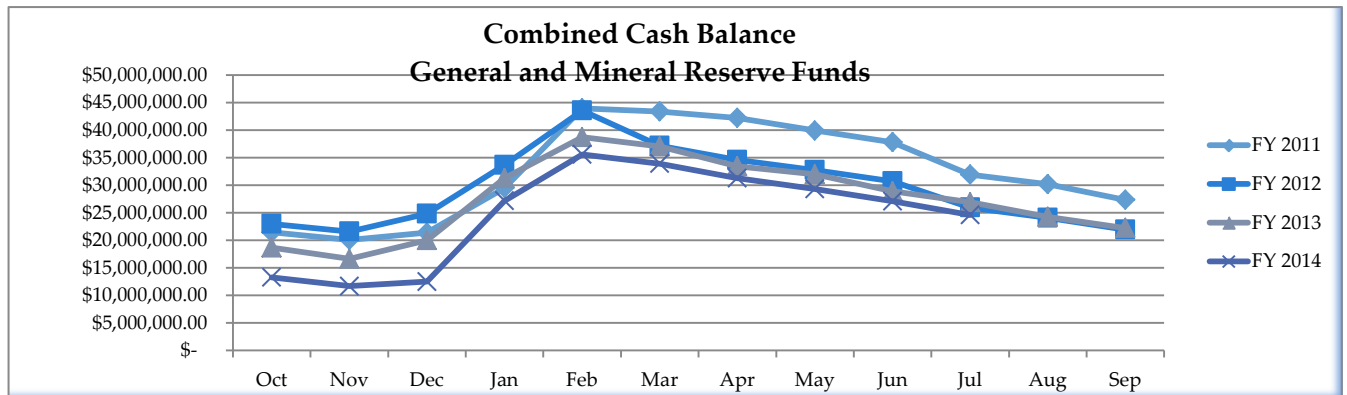
