COMMISSIONERS COURT APPROVING THE CONTINGENCY FEE CONTRACT OF REPRESENTATION WITH FERRER POIROT & WANSBROUGH, THE MACLEAN LAW FIRM, PC, AND FEARS NACHAWATI, FOR OPIOID LITIGATION
