ESTABLISHING A SPEED LIMIT OF 30 MPH ON A PORTION OF FERGASON ROAD A DISTANCE OF APPROXIMATELY FIVE TENTHS OF A MILE BETWEEN U.S. HWY 67 EAST AND CR 805 IN JOHNSON COUNTY, TEXAS -PRECINCT #4

The Johnson County Commissioners Court met on November 10, 2014 in regular session and held a public hearing for establishing a speed limit of 30 mph on a portion of Fergason Road a distance of approximately five tenths of a mile between U.S. Hwy 67 East and CR 805 in Johnson County, Texas Precinct #4.

The Public Hearing was properly published in the Cleburne Times Review, on the County Web Page and on the bulletin board of the Johnson County Commissioners Court at the Johnson County Courthouse on Sunday, November 2, 2014.

A motion was made by Commissioner Don Beeson and seconded by Commissioner Jerry Stringer to approve "Establishing a Speed Limit of 30 mph on a portion of Fergason Road a distance of approximately five tenths of a mile between U.S. Hwy 67 East and CR 805 in Johnson County, Texas Precinct #4." Said motion was approved by unanimous vote of the Commissioners Court on the 10th day of November, 2014.
