WHEREAS, the Judge of the County of Johnson on the 23<sup>rd</sup> day of April, 2020 issued a Sixth Amendment to Declaration of Local Disaster Due to Public Health Emergency; and

WHEREAS, the Commissioners Court has determined that the Sixth Amendment to Declaration of Local Disaster Due to Public Health Emergency for Johnson County should continue for a period of more than seven days for the health and safety of the public.


